WITHDRAWALS:

Any student wishing to withdraw from classes must give a 30-DAY NOTICE in writing, in person by parent or guardian, or by email. Phone calls will not be accepted as a notice. You ARE responsible for payments until the studio receives a notification.

Withdrawals are not accepted after January 1st with the exceptions of disability or relocation.

Once recital preparations are underway, we can no longer fill someone's place in the class. ALL remaining monthly tuition and costume balances will still accrue for any student that does not adhere to the withdrawal policy.

***Make-up Classes:** Due to our varied curriculum, Cydni's School of Dance is not able to offer "make-up classes" for student absences. Please make regular attendance a priority.

***Refunds:** There are NO refunds for missed or dropped classes. Tuition is based on enrollment not attendance. Refunds will not be issued on special orders that are not accepted back by the company (costumes). **Once costumes are ordered, no refund will be given.**

Additional Fees:
***Costume fees are due by October 15, 2018.** A letter will be sent home with your child stating amount owed. All costume fees must be paid in full to guarantee a costume will be ordered.
***Recital fees are due by March 15th, 2019.** This fee helps cover the cost of the end of the year rehearsal and recital.
